## **Reports from Directors**

#### 1. President

 Report was given orally with emphasis on developing a regional style with respect to Junior chess to give greater autonomy.

### 2. Finance Director

- Still trying to secure a source of funding for Chess Scotland.
- Funding for next year will give priority to the Commonwealth over the Olympiad however we are hoping the Commonwealth will be cost neutral.
- SJCAET will be approached to see if there is any assistance for the Glorney
- Delay in Audited Accounts, should be available for next Council Meeting



# 3. Technical Director – Ken Stewart

 Due to delay in FIDE confirming the new Rules for Chess, the new rules book will be produced April/May 2014

## 4. Grading Officer – Douglas Bryson

• We are unable to FIDE rate Spens and Richardson due to the FIDE rules on having a licenced arbiter present. Only way it could be done would be to have a licence non playing captain on each side.

## 5. Membership Secretary - Dick Heathwood

- Statistics are published every month and new members are welcomed on the Chess Scotland Website.
- The list of current members published on the website continues to be updated regularly, typically once ore more often per week.

## 6. Scottish Championship Director – Alex McFarlane

- Commonwealth is progressing well. Still looking to confirm a venue as Strathclyde are looking for 12K for a venue
- Provisional dates are 30<sup>th</sup> June 8<sup>th</sup> July
- Having real issues finding a sponsor so would like help from the Marketing Director in finding and obtaining a sponsor

## 7. Executive Director / Fide Delegate

- Had meetings with MSP over Chess in Schools and funding for Commonwealth
- Working with Alex on the Commonwealth
- Aiming to make a decision on our candidate for the FIDE and ECU elections at the nearest Council meeting.

## 8. Standards Committee - Dick Heathwood

- The Standard Committee respects confidentiality. Having said that if someone involved with a complaint decides to "go public" by releasing information even on what they assume is a limited basis, identities cannot be protected beyond that point. The wishes that people are named and shamed would open up the organization to potential legal challenge
- There is a procedure in place for monitoring someone through a suspension and for considering any application for reinstatement



• It was suggested that the Appeals Board should report to the AGM on the appeals they had considered during the year

#### **Election of Office Bearers**

- A point of order was raised stating that the Executive Director, Andy Howie was in fact not a
  member of Chess Scotland when the nominations were made. This prevents him from
  nominating someone and holding office.
- David Congalton pointed out that Andy had in fact paid his membership twice. He was paying for something in lieu of membership and also taking out a membership on top of that
- We are trying a new way of paying for membership and could not start it until the AGM agreed to it. It was agreed prior between the President, Treasurer and Membership Secretary that once the AGM were informed of what we were trying, then we could start. Given that the money paid in would exceed Patron membership for a year then Andy was considered to be a member.

- Chess Scotland has to find a way to move forward. One of the key areas would be to sort out the noticeboard which is a source of many of the issues seen. Reconciliation can only work if both sides go into it wanting it to work.
- We need to look bringing in a time bar for people joining Chess Scotland so they can't join the night before an AGM and get a vote

Stephen Hilton, Proposer Ian Brownlee Seconder Chris Hampton

- Chess Scotland need to take a look at itself and heal the internal fighting. A neutral looking in would be horrified at what they saw
- There has to be transparency in all actions

## **AOCB**

Disallowed Motions from August 2013 AGM

- It does not appear that Chess Scotland has a policy of monitoring someone to make sure they
  follow through when suspended. Standards Committee made a decision but we don't seem to
  be following it through as the person involved is still getting involved with Juniors and Junior
  decisions
- Chess Scotland has worked within the parameters of the decision from the Standards Committee. What we do have to do is to give the Standard Committee real power so it can act when people don't follow what they are supposed to do. The person referred to has not undertaken regulated work under Chess Scotland since suspension.
- The person involved has never been publically named. Chess Scotland have a duty of care to inform people he was not allowed to work with kids. It was never reported to Disclosure Scotland
- People come on and off the list for all sorts of reasons. If CS were to say that you would never be a Coach / Arbiter again, this would be a different process from the routine advice of additions and removals. The relevant authorities would then investigate the circumstances (A percentage of referrals are dismissed as being motivated by malice.) If the Government Body's (Disclosure Scotland)investigations concluded that the individual was unsuitable to work with children (or with protected adults as the case may be) every person with interest would be notified



- The President of Chess Scotland does not have the right to determine what can and can't be put on the agenda.
- The Agenda has to be checked and ratified before published as we can't let just anything there. All motions have to be competent and not personal. In this case the motions were just that! The President has the right to make sure the meeting runs smoothly.
- The motions were read out and after a short discussion, the meeting voted on whether the President was correct in blocking the motions

Ratified as CS cannot simply allow any motion put forward to automatically appear on the agenda 14-8

The meeting was then asked if we can allow new business since the start of the AGM in August

# Appendix 1.

Statement to the AGM by Steve Mannion Snr.

I feel very concerned over the ongoing and current harassment of a former Chess Scotland official and the related, continuing criticism of the Standards Committee and Chess Scotland.

In fact, my concern is sufficiently strong that I would recommend that the AGM give themselves pause for thought and consider the following facts. I speak out as the person who investigated the original complaint which contained three separate allegations (all from the same person and directed against one other Chess Scotland official). As a result of my investigations, I found two of the complaints unsubstantiated and referred a third to the Standards Committee. The substantial evidence I had collated from the complainer and many witnesses that I contacted who were all at the event (Maribor in Slovenia) was passed on to the committee. They upheld the complaint and offered recommendations with a view to preventing a recurrence in future circumstances. In spite of the finding in favour of the Complainer an appeal was made against the decision of the Standards Committee. Although I am Convener of the Appeal Board, I took no part in the consideration of the five page, over two thousand word Appeal. That Board was chaired by an eminent and experienced Tribunal judge and they rejected the appeal.

I can categorically state that any suggestion of alcohol consumption by the official was not mentioned to me in my several interviews and conversations with the complainer in November/December 2012 and in January 2013. Equally, none of various witnesses that I interviewed expressed any comment that alcohol consumption was in any way relevant to the complaint. It was not until after the decisions of the Standard Committee and the Appeal Board that alcohol consumption was first mentioned by the complainer, some four months plus after the event. At that point I revisited the evidence and made further inquiry and found no evidence to substantiate the claim.

What this AGM does with this information is for them to decide but if this matter ends up in court, as it could do, then I shall be prepared to give evidence based on my enquiries and what the witnesses who were in Slovenia told me.

I regret that I cannot be with you to deliver this message personally but long before this date was agreed for the AGM I had another long standing engagement which I intimated.
